SUBJECT: Authorization for MCDOT to remove CTH A (S. 68th St.) from the CTH system by amending Milwaukee County Code of General Ordinances Chapters 68.01 and 71.31

POLICY

Per Section 83.025 of the Wisconsin Statutes, Milwaukee County has authority to make changes to the County Trunk Highway (CTH) System.

BACKGROUND

On September 26, 2013, the Milwaukee County Board approved a resolution to execute a Jurisdictional Transfer Agreement for Milwaukee County to transfer ownership and maintenance to the City of Franklin for CTH A (S. 68th St.) from STH 100 (W. Ryan Rd.) to 1285 feet south of W. Puetz Rd., including the road right-of-way.

On November 15, 2013 Milwaukee County and City of Franklin entered into a Jurisdictional Transfer Agreement for transfer of ownership and maintenance of CTH A (S. 68th St.) from STH 100 (W. Ryan Rd.) to 1285 feet south of W. Puetz Rd., including the road right-of-way.

On June 16, 2015, the City of Franklin Common Council approved a resolution to accept the jurisdictional transfer from Milwaukee County for CTH A (S. 68th St.) from STH 100 (W. Ryan Rd.) to 1285 feet south of W. Puetz Rd., including the road right-of-way.

On June 29, 2015, the CTH A (S. 68th St.) jurisdictional transfer to the City of Franklin was completed according to the Jurisdictional Transfer Agreement and therefore needs to be removed from the CTH system by amending the applicable Milwaukee County Code of General Ordinances, Chapter 68.01 and Chapter 71.31.

RECOMMENDATION

The Director of Milwaukee County Department of Transportation (MCDOT) recommends removal of CTH A (S. 68th St.) from the CTH system as it no longer under the jurisdiction of Milwaukee County by amending Milwaukee County Code of General Ordinances Chapter 68.01 and Chapter 71.31.

FISCAL EFFECT

No property tax levy impact as funds for this purpose are available within the approved capital project for the S. 68th St. (CTH A), Project WH02012.

A RESOLUTION AUTHORIZING OFFICIALS TO ACCEPT JURISDICTIONAL
TRANSFER OF S. 68TH STREET (CTH A) FROM W. RYAN ROAD TO
APPROXIMATELY 600 LINEAL FEET SOUTH OF W. PUETZ ROAD.

WHEREAS, the City of Franklin and Milwaukee County have discussed the merit of transferring several roadways; and

WHEREAS, on November 15, 2013 City of Franklin and Milwaukee County entered into a jurisdictional transfer agreement for said section of roadway; and

WHEREAS, Milwaukee County has satisfactorily fulfilled the terms of the 2013 agreement; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of Franklin that the Common Council conditionally accepts the jurisdictional transfer from Milwaukee County of S. 68th Street (CTH A) from W. Ryan Road to approximately 600 lineal feet south of W. Puetz Road.

This agreement being subject to review and approval of the City Attorney.
