Daire and her family have been working with the Life Navigators Family Support program for years. As she and her caregiver have gotten older, her needs have changed and she now requires a higher level of support. With help from the Life Navigators team, Daire has been able to access safe transportation, work with a disability benefit specialist to obtain MAPP funding and is on her way to getting connected to Long Term Care funding. These added services will help Daire stay as independent as possible and assure her family she will have the support she needs when her caregiver is no longer able to provide it.







Please share a challenge from the second half of 2024.

- Delay in Access to Long Term Care services
- One of the main things we look at first when working with a new family is if they are connected to Long Term Care for their loved one. Long Term Care services (like Family Care and IRIS) are critical to building a network of support for aging caregivers. Having services in place reduces caregiver strain, enhances the quality of life for the individual with a disability and provides a safety net in the event of an emergency. The second half of 2024 saw the beginning of a waitlist with the ADRC for Options Counseling. This waitlist is now over 3 months. This has caused a critical delay in getting families the services they require to do adequate futures planning.

Life Navigators has continued to see an upsurge in the number of families who have questions on guardianship, or do not have anyone to serve as successor guardian for their loved one if something were to happen to the current guardian. We are addressing this need by producing materials to better explain guardianship and to offer Life Navigators Corporate Guardianship services (or other similar programs) as a future possibility.
