RE: Report from the Milwaukee Art Museum, Inc.

Fiscal 2016 – Q1 update (November 2015)

Summary

The mission of the Milwaukee Art Museum, Inc. (Art Museum) is to serve the community and present art as a vital source of inspiration and education. Through exhibitions and related programs, the Art Museum is committed to bring people together to inform, educate and engage in conversation around art.

For the quarter ended February 29, 2016, the Art Museum presented the following major exhibitions; Larry Sultan: Here and Home which ran through January 24, 2016 and Sam Francis: Master Printmaker which runs through March 20, 2016. In addition, Nature and the American Vision: The Hudson River School opened February 26, 2016. Our permanent collection was off view to the public until November 24, 2015 as part of our renovation, which was partially funded by Milwaukee County. Attendance was 14% above plan for the year through February; ending at just over 166,000 visitors for the six months ended February 29, 2016, with approximately 51% coming from Milwaukee County. School tours welcomed over 18,000 students to the Art Museum for the six months ended February 29, 2016 with over 57% of school students from Milwaukee County.

Financial results

Attached are the financial results for the six months ended February 29, 2016. The Art Museum plans to end the year with a balanced operating budget. The Art Museum contributed revenue accounted for over 58% of all revenue sources. The earned revenue was just over 30% of total revenue. The remaining 12% of revenue was primarily due to the distribution to operations from the endowment fund.

Looking forward

The Art Museum's current exhibitions are Nature and the American Vision: The Hudson River School, which is open until May 8, 2016 and Taking Center Stage: The Lanford Wilson Collection of Self-Taught Art. Future exhibitions include: American Epics: Thomas Hart Benton and Hollywood, opening June 10, 2016; and From Rembrandt to Parmigianino: Old Masters from Private Collections, opening July 29, 2016.

Regarding the O'Donnell property, Museum and County legal counsel are in the document drafting stage and making good progress. In addition, MAM is working on its due diligence as specified in the approved term sheet.

The Art Museum's search for a new director is progressing and we hope to have a new Director in place by late summer.
