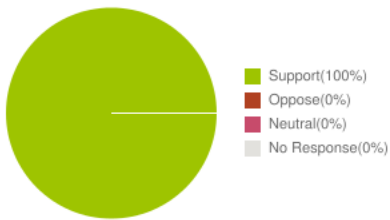

#### Overall Sentiment



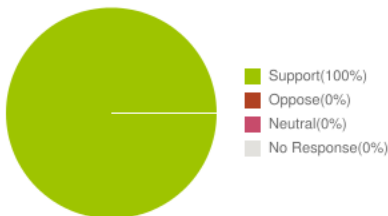

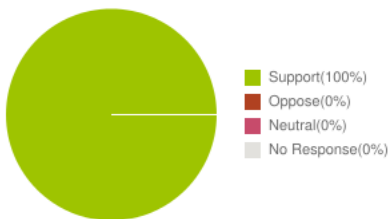

As a member of the City/County Task Force on Climate Change and Economic Equity representing the Milwaukee Area Labor Council I appreciate the work that has gone into identifying possible uses for ARPA funds by Milwaukee County. To the extent that funds would be allocated to either of these identified areas: 2.7 Job Training Assistance (e.g., Sectoral job-training, Subsidized Employment, Employment Supports or Incentives) and 2.9 Small Business Economic Assistance (General) we urge consideration of collaboration with the City of Milwaukee and Employ Milwaukee to coordinate workforce development and business development to position workers and companies in Milwaukee County to be successful in employment and contracting relative to address climate change (Electric Vehicle charging stations, weatherization, LED lighting conversions, tree planting, solar installation, manufacturing of components for renewable energy, these are but a few examples). We believe helping to prepare un- or under-employed

Milwaukee County residents for the green jobs of the future would be a good expenditure of some of Milwaukee County's ARPA funding.
