This resolution creates a Work Group to develop a plan to reestablish the Milwaukee County Public Art Program which in part requires public art be incorporated into eligible capital improvement projects. The Work Group would prepare suggestions for the County Board to review regarding defining project eligibility and options regarding the sustained financing of the program.
