A. The Office of Performance, Strategy & Budget requests retroactive authority to apply, and accept, for the 2018 Justice Assistance Grant from the U.S. Department of Justice.

B. Approval of this request will result in possible total 2018 JAG grant funds of \$968,083 being provided to the following agencies:


Milwaukee County:	\$525,363
City of Milwaukee:	\$420,263
City of West Allis:	\$22,457

C. It is anticipated that the County will not spend any of the 2018 JAG dollars in 2018. This is because the award is announced late in the year and because of such, no entity can spend funds until verification/acceptance of the award is actually announced. No County departments have budgeted for these funds in the 2019 budget process because 2019 requests were due prior to the JAG solicitation announcement. If awarded departments will be required to submit a fund to DAS PSB transfer to receive funds and increase expenditure authority.

D. This grant does not require a local match, however staff time is required because DAS-PSB is the fiscal agent for the grant. DAS-PSB will, upon receiving verification of expenses submitted for reimbursement consistent with the approved spending plan, transfer funds to the appropriate account from the trust account that will be created. In addition, DAS-PSB will make payments to the Wisconsin Policy Forum and the municipalities listed above for eligible costs upon receipt of appropriate documentation.
