From the Chief Deputy, Office of the Sheriff, requesting authorization to accept a State of Wisconsin Department of Transportation contract No 2 for the 2020 Traffic Mitigation I-94 NS Project North Segment from January 1, 2020 through July 1, 2020 to mitigate traffic impacts and ensure emergency response capabilities are not adversely impacted during construction, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, the State of Wisconsin Department of Transportation (WisDOT) has authorized funding for the Interstate 94 (I-94) North South Project North Segment with the project area identified as interstates I-94 from the Milwaukee County Line on the south, College Avenue on the north, and local alternate route streets within two miles of the interstate roadways; and

WHEREAS, WisDOT has requested the implementation of a comprehensive and cost-effective transportation management plan, that will ensure the safety, accessibility, and mobility for the traveling public in the project area; and

WHEREAS, WisDOT requires that the contract be executed for the period beginning January 1, 2020, through July 1, 2020; and

WHEREAS, the Office of the Sheriff agrees to maintain a properly trained Deputy Sheriff patrol dedicated to the project area for first, second, and third shift, twenty-four hours per day, seven days a week, beginning January 1, 2020, and ending July 1, 2020; and

WHEREAS, the Office of the Sheriff will bill WisDOT for Deputy Sheriff straight time, with overhead included at \$52.02 per hour in 2020; and

WHEREAS, the Office of the Sheriff will bill WisDOT for Deputy Sheriff overtime at \$56.89 per hour in 2020; and

WHEREAS, the Office of the Sheriff will provide a properly equipped and enhanced construction patrol vehicle and squads, with the cost of fuel and maintenance to be billed at actual cost not-to-exceed \$41,700 in 2020; and

WHEREAS, the Committee on Finance and Audit, at its meeting of December 12, 2019, recommended adoption of File No. 19-862 (vote 6-0); now, therefore,

BE IT RESOLVED, the Office of the Sheriff is hereby authorized to accept the State of Wisconsin Department of Transportation contract for the period effective January 1, 2020, through July 1, 2020, for the 2020 Traffic Mitigation Interstate 94 North South Project North Segment funding in the amount of \$307,303.08.
