A. The Interim Director, Department of Health and Human Services, is requesting authorization to designate the Wisconsin Partnership for Housing Development (WPHD), a non-profit housing development agency, as a Community Housing Development Organization (CHDO) for Milwaukee County.

B. There are no direct costs, savings, or revenues associated with this action. HOME participating jurisdictions must designate one or more Community Housing Development Organizations (CHDOs). Designating the Wisconsin Partnership for Housing Development (WPHD) as a CHDO would allow Milwaukee County more options and flexibility with HOME funds as well as involve an agency that has expertise dealing with foreclosed single family homes.
