 - A. Parks is requesting authority to enter into a lease with Milwaukee Christian Center for certain space within the Kosciuszko Community Center.
 - B. A lease with MCC will generate a rental income of \$1,000 per month and \$12,000 annually for the initial term. An additional annual maintenance fee of \$550 will also be received.
 - C. Parks includes lease revenue in the yearly budget so there are no budgetary impacts from this lease.
 - D. No assumptions or interpretations were utilized to prepare this form.
