

3 From the Director and Chief Information Officer, Information Management Services
4 Division, Department of Administrative Services requesting authorization to enter a
5 multi-year contract for total fees of \$184,110 with RPI Consultants, by recommending
6 adoption of the following:

8 **A RESOLUTION**

10 WHEREAS, Section 59.60(12), Wisconsin State Statutes, requires the
11 Milwaukee County Board of Supervisors to approve contracts that will use funds from
12 future budgets; and
13

14 WHEREAS, as a part of the Information Management Services Division (IMSD),
15 Department of Administrative Services (DAS), ongoing cost optimization efforts and
16 utilizing Division strategic pillars to maximize the value of technology within Milwaukee
17 County (the County), DAS-IMSD is working with vendors to identify savings, where
18 possible, through the use of multi-year contracts; and
19

20 WHEREAS, with departmental input, it was determined that RPI Consultants
21 represents technology that IMSD-DAS finds beneficial for long-term use for the County;
22 and

24 WHEREAS, as part of a three-year agreement with RPI Consultants, the annual
25 administrative fee of \$3,068.50 will be waived; and
26

27 WHEREAS, Section 56.30(9), Milwaukee County Code of General Ordinances
28 (the Code), requires that a written contract be signed and executed before an outside
29 party performs professional services; and
30

31 WHEREAS, Section 56.30(8) of the Code states that the Office of the
32 Comptroller shall deny payment for professional services if the conditions of Chapter 56
33 of the Code have not been met; and

35 WHEREAS, the Committee on Finance, at its meeting of December 11, 2025,
36 recommended adoption of File No. 24-740 (vote 6-0); now, therefore,

38 BE IT RESOLVED, the Information Management Services Division (IMSD),
39 Department of Administrative Services (DAS), is hereby authorized to enter into a
40 three-year agreement with RPI Consultants for the term effective September 1, 2025,
41 through August 31, 2028, in the amount of \$184,110; and

44 BE IT FURTHER RESOLVED, the Director and Chief Information Officer, IMSD-
45 DAS, the Office of the Comptroller (the Comptroller), County Executive, and Corporation
46 Counsel are authorized to sign and execute the contract with RPI Consultants; and

48 BE IT FURTHER RESOLVED, the Milwaukee County Board of Supervisors
49 (County Board) hereby waives Sections 56.30(8) and (9), Milwaukee County Code of
50 General Ordinances and authorizes the Comptroller to retroactively pay RPI
51 Consultants for services provided before all parties signed the agreements; and

53 BE IT FURTHER RESOLVED, the County Board hereby authorizes the
54 Comptroller to process payment prior to services being rendered each contract year.
