 - A. This is a request for authorization to execute a temporary easement with Everstream for underground telecommunication installation on 0.1 acres of Honey Creek Parkway. The fiber line was installed in 2021 without obtaining Parks authorization. The easement will be consistent with other easements expected to be granted in this location for other fiber optic companies needing to relocate their fiber optic lines off Wisconsin Ave bridge due to the bridge demolition scheduled in 2025.
 - B. There is no direct cost to the County except staff time to review the after the fact easement application. The standard permit application fee will be doubled because it is an after-the-fact permit, and there will be a lumpsum payment of approximately \$4,000 for past due rent.
 - C. There will be an annual rent for the easement which is \$1,073 in 2024 and escalates annually by 3% for the life of the term.
