The Clerk of Circuit Court is requesting permission to increase the juror transportation fees from \$3.00 to \$9.00. The ordinance set the fee at \$2.00 per day in 1983. The County Board increased it to \$5.00 per day in 1994, and then subsequently set it at the current rate of \$3.00 per day in 2003. Currently Milwaukee County ranks in the bottom 10 percent of juror compensation in all of Wisconsin counties. This increase will assist in encouraging Milwaukee County citizens in performing their civic duty.

In anticipation of the transportation increase, it is expected that the annual expenditures will increase by \$216,000. This computation is derived by 36,000 juror days with the increase of \$6.00 per day. This increase of expenditures would be absorbed in our current budget. For subsequent years, the Clerk of Circuit Court would budget accordingly for the proposed increases.
