#### **POLICY**

Authorization to reallocate \$131,155 from a water pumping system project at the Farm and Fish Hatchery to other repair and replacement projects not covered by insurance.

### **BACKGROUND**

File No. 14-668 authorized \$200,000 from the Appropriation for Contingencies account to be used for the construction and installation of a new water pumping system on the Farm and Fish Hatchery grounds. In May 2016, the County Board of Supervisors in File No. 16-255 authorized carryover of the remaining funds from that project to DPRC's 2016 operating budget. The water pumping system is installed and the project has been closed out.

The DPRC is requesting authorization to redirect the remaining \$131,155.00 for repair and replacement projects resulting from vandalism and property damage not covered by insurance. Projects include:

- Lincoln Memorial Drive light pole replacements
- Lake Park tennis court fence repair
- Lincoln Park Henry Aaron Field fence repair
- Grant Park Picnic Shelter #5A roof shingle replacement
- Farm & Fish Hatchery roof repair
- Boerner Visitor's Center water damage improvements

## **RECOMMENDATION**

The DPRC recommends authority to redirect \$131,155.00 for repair and replacement projects resulting from vandalism and property damage not covered by insurance.
