The Office of the Sheriff is requesting to create 3.0 FTE Deputy Sheriff positions to form a new Crisis Assessment and Response Team (CART). The full cost of the requested positions are offset by revenue from BHD reserves. The Milwaukee County Mental Health Board approved the use of reserves for the CART team in 2020. The annual salary and social security cost of a Deputy Sheriff position is between \$57,197 and \$82,046, depending on the step the positions are filled at. This resolution also authorizes DAS and the Office of the Comptroller to process an administrative transfer to recognize the contribution from the Mental Health Board reserves. This resolution has no net fiscal impact to the Office of the Sheriff.

In subsequent years, the three Deputy Sheriff positions may continue to be funded through BHD Reserves, may be funded inside the levy target for the Office of the Sheriff, or be abolished.
