From the Director of Total Rewards, Department of Human Resources, requesting approval of the classification of two Community Intervention Specialist positions (title code 00008000, pay grade 24), and one Lead Community Intervention Specialist position (title code to be determined, pay grade 27) in the Department of Health and Human Services, by recommending **REJECTION** of the following:

A RESOLUTION

WHEREAS, the Interim Director, Department of Health and Human Services (DHHS), is requesting the creation of two Community Intervention Specialists, and one Lead Community Intervention Specialist; and

WHEREAS, the request to create the positions is being reviewed separately by the Committee on Finance and Audit as part of File No. 17-540; and

WHEREAS, developing and implementing a new trauma strategy is required to make progress in addressing racial and ethnic disparities while appropriately reducing Milwaukee County’s overall jail population; and

WHEREAS, the requested positions are critical to supporting a post-stabilization process that attempts to divert an individual with mental health or substance abuse issues from jail to supportive housing placement; and

WHEREAS, the Lead Community Intervention Specialist has additional responsibility for coordinating the release planning process to ensure successful placement and referrals to the Behavioral Health Division for treatment; and

WHEREAS, the DHHS has been awarded funding through the John D. and Catherine T. MacArthur Grant to offset the cost of this critical program; and

WHEREAS, the Department of Human Resources is responsible for assessing the duties associated with the position and providing a job title and compensation recommendation to the Committee on Personnel; and

WHEREAS, the Committee on Personnel, at its meeting of July 17, 2017, recommended rejection of File No. 17-541, due to a failed motion to recommend adoption (vote 2-3); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby adopts the classification recommendation for the positions as outlined in the memo hereto attached to this file and summarized as below:
