  - A. Authorization to enter a Vendor Permit Agreement for bicycle Rental Concession Services at the Lakefront with Funtime LLC D/B/A Wheel Fun Rentals. The current vendor permit expires in 2021 and Wheel Fun wishes to enter into a longer agreement in order to make an investment into the facility and surrounding area. The agreement is for five years with two one-year extensions.
  - B. The current agreement expires in 2021. Revenues are already included in the current budget year. If the new agreement is executed, Wheel Fun will make at least \$80,000 of improvements to the facility and surrounding area within the next year. Additionally, Wheel Fund will pay \$7,750 in the months of June, July, August, and September, plus 23% of gross receipts greater than the total amount invoiced. Wheel Fun will also contribute \$100 in each of its operating months to offset the cost of utilities.
  - C. Entering into this vendor permit agreement will ensure a steady revenue stream in years 2020-2025 as noted above. Revenues are already included in the current budget year. Revenue to Parks totals \$155,000 in the first five years of the contract and \$31,000 in each of the extensions, plus 23% of gross receipts greater than the total amount invoiced. Additionally, Wheel Fun will contribute \$100.00 per operating month toward utilities.
