

- A. Approval of this resolution will authorize and direct a **2017** appropriation transfer to reallocate \$100,800 in general obligation bond financing from Capital Improvement Project WP52301 – Lake Park Steel Bridge to Capital Improvement Project WP48401 Lake Park Ravine Bridge.
 - B. This action will reduce expenditure authority in the Steel Bridge project and increase general obligation bond financing in the Ravine Bridget project by \$100,800, to \$600,800. Private contributions (revenue) will be reduced by \$100,800, from \$2,000,000 to \$1,899,200.
 - C. No budgetary impacts in 2016. For 2017, Capital Improvement expenditures and revenues will each be reduced by \$100,800.
 - D. No assumptions were used.
