Hughes from the Unclassified Position of Deputy Sheriff Director (working title Inspector) to the Unclassified Position of Administrator Sheriff (working title Chief Deputy), in accordance with County Ordinances and Wisconsin State Statutes, Section 59.26(1), by recommending adoption of the following:

A REVISED RESOLUTION

WHEREAS, Section 59.26(1), Wisconsin State Statutes, makes provisions for counties under civil service to allow the Office of the Sheriff (the Sheriff), in conformity with the Milwaukee County Code of General Ordinances (the Code), to grant leaves of absence to deputies for appointment to higher positions; and

WHEREAS, on September 29, 2005, the Milwaukee County Board of Supervisors (County Board) created Section 17.193 of the Code, to provide a mechanism for the Sheriff to grant leaves of absences; and

WHEREAS, under Section 17.193 of the Code, the Sheriff may not grant a leave of absence until the Sheriff first secures the consent of the County Board by resolution duly adopted by the County Board; and

WHEREAS, granting leaves will enhance the Sheriff’s ability to administer her office efficiently, and appoint subordinates in a manner most effective in fulfilling the statutory and constitutional duties of her office; and

WHEREAS, the Sheriff requests a continued leave of absence for the following employee:

Current unclassified position:

Deputy Sheriff Director (Unclassified) (working title Inspector), on leave from the Classified position of Captain

Employee: Daniel R. Hughes

New regular appointment unclassified position:

Sheriff’s Department Administrative Fac (working title Chief Deputy) Non-Civil Service – Unclassified

Effective date to extended current leave of absence:

Immediately upon adoption of resolution and appointment to unclassified position
