

- A. Implementation of Wisconsin Statutes 59.21(31) with regard to purchase of professional service agreements (under the Milwaukee General Ordinance Chapter 56) for Capital projects requires County Board passive review for award the initial agreement, or fee extension(s) to the original agreement, when the total contractual fee exceeds \$100,000 but is less than \$300,000.
- B. A fee increase to an existing professional service agreement with Interfluve to provide professional design services for 2017 Capital Project WP548 – Kletzsch Park Dam is being requested that would add not to exceed \$127,560.00 to the current agreement resulting in a total agreement value not to exceed \$207,485.00.
- C. The 2017 capital budget, via fund transfers, included a total of \$1,309,536.00 for capital project WP548 – Kletzsch Park Dam. There are sufficient funds in the current WP548 capital budget to award the requested professional services agreement fee increase to Interfluve. The construction will start in 2018 utilizing the currently approved budget.
