

Approval of this resolution will affirm Milwaukee County's support to be the "designated recipient" of the Federal Transit Administration Section 5310 Program within the Milwaukee Urbanized Area. The Wisconsin Department of Transportation (WisDOT) decided not to administer this grant program on behalf of the grantees in the Milwaukee Urbanized Area any longer and, instead, allow one of the grantees to become the designated recipient. The Milwaukee County Department of Transportation is in discussions with the Wisconsin Department of Transportation (WisDOT) and Southeastern Wisconsin Regional Planning Commission (SEWRPC) to become the designated recipient, including the potential for full reimbursement of costs to administer the grant program on behalf of smaller grantees within the area.

It is anticipated that a separate agreement will be submitted to the County Board if negotiations are successful. Approval of this resolution will require the expenditure of staff time to pursue and develop the agreement. No other appropriation of funds is required.
