A. The Department of Administrative Services (DAS) and the Office of the Comptroller (Comptroller) are requesting approval to lapse expenditures and revenues associated with completed/abandoned projects in accordance with Section 32.91(7) of the Milwaukee County General Ordinances. The DAS is required by Section 32.91(7) to prepare an annual report on operating and capital carryovers.

B. There are no direct costs. See item C for budgetary impact.

C. Operating budget capital outlay, equipment and major maintenance appropriations recommended to be lapsed total \$9,478,917. The total amount includes \$8,391,493 that relates to the Countywide Budget Abatement Account; therefore, the amount being lapsed within departments totals \$1,087,424.

Non-airport capital project fund expenditure appropriations of \$4,382,169 and budgeted revenues of \$767,616 are requested to be lapsed.

Excluding Airport appropriations and revenues, a net cash surplus of \$547,711 will be applied to the County's general fund. Unspent bond proceeds of \$3,066,848 from the lapsed capital projects will be deposited into the County's debt service reserve.

Airport capital project fund expenditure appropriations of \$3,163,650 and budgeted revenues of \$3,223,354 are requested to be lapsed. The resulting cash deficit of \$59,706 will be accounted for in the appropriate airport balance sheet account.
