From the Director, Office of Emergency Management, requesting authorization to create two (2) Full-Time Paramedics to provide adequate staffing levels for medical operations at our contracted venues and also operate as part of the Community Oriented Regional EMS (CORE) Team, by recommending adoption of the following:

**A REVISED RESOLUTION**

WHEREAS, the Emergency Medical Services (EMS) Division, Office of Emergency Management (OEM), provides medical coverage to support contracted venues within Milwaukee County and normally staffed venues, to provide on-site EMS response capabilities; and

WHEREAS, OEM strives to ensure contractual obligations are being met while still being able to respond to requests for assistance for normal duties in a quick and timely manner; and

WHEREAS, the two, Full-Time Equivalent, Paramedic and Trainer (Hourly) positions, created pay period 13, beginning June 12, 2022, are projected to cost \$27,262 each, or \$54,524, for the remainder of 2022, and \$50,629 each, or \$101,258 for the full year in 2023; and

WHEREAS, to provide adequate staffing, including contracted venues where many people gather, it is recommended five additional positions be created for OEM, fully offset with additional revenue, to provide high-quality EMS services to the community; and

WHEREAS, the Committee on Finance, at its meeting of May 19, 2022, recommended adoption of File No. 22-354 (vote 7-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes and approves the following position actions for the Emergency Medical Services (EMS) Division, Office of Emergency Management (OEM), effective pay period 13, beginning June 12, 2022, as shown below:
