6 (ITEM) From the Chief Judge, requesting authorization to postpone the issuance
7 of a Request for Proposals for programs included in Org. Unit 2900-Pretrial Services for
8 a period of one year and to continue existing Professional Services Contracts with
9 Wisconsin Community Services, Inc., and JusticePoint, Inc., in 2016, by recommending
10 adoption of the following:

12 **A RESOLUTION**

14 WHEREAS, on November 10, 2014, the Milwaukee County Board of Supervisors
15 adopted the 2015 Milwaukee County Budget (File No. 14-765), which was approved by
16 the County Executive and which included funding for programs in Org. Unit 2900-
17 Pretrial Services; and

19 WHEREAS, as a result of a competitive Request for Proposals (RFP #6723)
20 issued on April 13, 2012, JusticePoint, Inc., and Wisconsin Community Services, Inc.,
21 were unanimously selected as service providers for the period of January 1, 2013, to
22 December 31, 2015; and

24 WHEREAS, programs in Org. Unit 2900-Pretrial Services are normally subject to
25 a competitive bid process every three years and are due to be bid in 2015 for a service
26 period of January 1, 2016, to December 31, 2018; and

28 WHEREAS, Milwaukee County is currently replacing the existing Milwaukee
29 County Pretrial Services Information System; and

31 WHEREAS, development of the new information system was originally expected
32 to begin in November 2013, but began much later than anticipated with the anticipated
33 implementation date now being September 1, 2015; and

35 WHEREAS, access to the new information system is essential for potential
36 service providers during the RFP process; and

37
38 WHEREAS, postponing the issuance of the RFP for Org. Unit 2900-Pretrial
39 Services programs will have no fiscal impact; and

41 WHEREAS, the Committee on Judiciary, Safety, and General Services, at its
42 meeting of April 9, 2015, recommended adoption of the Chief Judge's request (vote 5-
43 0); and

45 WHEREAS, the Committee on Finance, Personnel, and Audit, at its meeting of
46 April 16, 2015, also recommended adoption of the Chief Judge's request (vote 7-0);
47 now, therefore,

49 BE IT RESOLVED, the Milwaukee County Board of Supervisors does hereby
50 authorize the Chief Judge to postpone the issuance of a Request for Proposals for
51 programs included in Org. Unit 2900-Pretrial Services, for a period of one year and to
52 continue existing Professional Services Contracts with Wisconsin Community Services,
53 Inc., and JusticePoint, Inc., in 2016.
