A report from the Director, Department of Health and Human Services, requesting the creation of 0.75 FTE Consultant Dietitian in Aging and Disabilities Services, by recommending adoption of the following:

A RESOLUTION

WHEREAS, a Consultant Dietitian position is being requested for the Aging and Disabilities Services Division, Department of Health and Human Services (DHHS); and

WHEREAS, the Consultant Dietitian position will support the participants within the Senior Dining Program with home delivered meal clients in providing nutrition education and counseling to address nutrition risk and malnutrition; and

WHEREAS, funding is available through American Rescue Plan Act Older Americans Act Title IIIC-2; and

WHEREAS, the request to create this new position within DHHS aligns with Milwaukee County’s strategic plan to ensure that we can continue in determining what, where, and how we deliver services to advance health equity; and

WHEREAS, the Department of Human Resources has reviewed this position change request, and has determined the appropriate classification of Consultant Dietitian, pay grade 27M, and has submitted a report included in this file; and

WHEREAS, the Office of Strategy, Budget, and Performance has reviewed this request with respect to need, appropriateness, and funding availability as required per Section 59.60(10), Wisconsin State Statutes, and has submitted a report included in this file; and

WHEREAS, the Committee on Personnel, at its meeting of January 17, 2023, recommended adoption of File No. 23-149 (vote 4-0); now, therefore,
