RE: Overview of 2017-19 Biennial State Budget

MEMORANDUM

On February 8, 2017, Governor Scott Walker introduced his 2017-19 biennial state budget proposal ("Senate Bill 30 / Assembly Bill 64"). The Joint Finance Committee ("Committee") subsequently received briefings from major agency heads and held six public hearings around the state, including one in Milwaukee County at State Fair Park on April 5, 2017. Chairman Lipscomb was the first invited elected official to testify before the Committee during the Milwaukee County hearing. During the hearing, Chairman Lipscomb welcomed the Committee to Milwaukee County and requested that the Committee dedicate its attention and support to Milwaukee County's transportation infrastructure and human service programs, address the growing crisis in our juvenile correctional system, and revisit Milwaukee County's governance structure.

From May 1, 2017 to September 5, 2017, the Committee deliberated on these and many other topics. Many of the issues Chairman Lipscomb raised at the public hearing were addressed by the Committee and are reflected in Assembly Bill 64 as adopted by the Legislature.¹

Many Supervisors, including the Chairman and Members of the Transportation, Public Works and Transit Committee, requested information regarding an Assembly Republican proposal to require Milwaukee County to hold a binding referendum on its vehicle registration fee and, unless the referendum resulted in a positive vote, discontinue its application. Ultimately, that provision was not included in the final version of the budget and cannot be included through gubernatorial action on the bill.

As of this writing, the Governor has not yet signed the budget bill, but a number of vetoes are already expected, including:

- Modifications to Public Finance Authority
- Initial Applicability of the Repeal of Prevailing Wage Law
- Transportation Projects Commission Changes
- Transfer of Segregated Funds (WisDOT Fed Swap)
- Tolling Implementation Study
- Energy Efficiency Revenue Limit Adjustment
- School District Referenda Scheduling
- State Capitol Basement Renovations
- Local Regulation of Quarries

Once the Governor signs Assembly Bill 64, which is expected to occur on Wednesday or Thursday, deliberations on the 2017-19 officially come to a close. An overview of the Governor's actions will be provided once it becomes available.
