**PURPOSE OF CONTRACT**

The contract with Legal Action is amended to include an additional \$55,000 to fund Medicare outreach related services. This amendment is made possible due to the receipt of Medicare Improvements for Patients and Providers (MIPPA) and State Health Insurance Assistance Program (SHIP) grants. These grants were not anticipated during the 2018 Budget development process and therefore no grant service expenditures were planned. The total contract to provide legal assistance services is now revised to \$403,562.
