Approval of this resolution authorizes an initial contribution of up to \$30,000 in 2014 Milwaukee County Transit 5600 operating maintenance funds for bus stops and walkway improvements at Southridge, plus up to \$10,000 annually in operating funds for maintenance beginning in 2015, to provide improved bus service at the shopping center.
