Report from the Interim Director, Department of Health and Human Services, requesting authorization to sign Cooperation Agreements for years 2021, 2022 and 2023 designating Milwaukee County as an Urban County in order to receive Community Development Block Grant (CDBG) funds, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the United States (U.S.) Congress enacted the Housing and Community Development Act of 1974 (Public Law 93-383) as amended (The Act), providing Federal assistance for the support of community development activities, which are directed toward the specific objectives identified in Section 101 of The Act; and

WHEREAS, the U.S. Congress also enacted the Cranston-Gonzalez National Affordable Housing Act (Public Law 100-625) as amended, (NAHA) providing Federal assistance for, among other things, the HOME investment Partnership Program (HOME), which is intended to increase the number of families served with decent, safe, sanitary, and affordable housing and to expand the long-term supply of affordable housing; and

WHEREAS, The Act makes possible the allocation of funds to Milwaukee County (the County) for the purpose of undertaking only community development program activities identified in Section 105 of The Act; and

WHEREAS, NAHA makes possible the allocation of funds to the County for the purpose of undertaking housing programs identified in Section 211 of NAHA; and

WHEREAS, the County intends to apply to the U.S. Department of Housing and Urban Development (HUD) for funds authorized under The Act and NAHA; and

WHEREAS, The Act recognizes that the municipality may enter into Cooperation Agreements with the County in order to undertake housing and community development activities as authorized in Section 105 of The Act; and

WHEREAS, the County and the municipality have determined that joint action is an effective way to accomplish the purposes of said Act and NAHA; and

WHEREAS, counties in Wisconsin, pursuant to Section 59.01, Wisconsin State Statutes (State Statutes) and municipalities in Wisconsin, pursuant to Section 66.0301, State Statutes have the necessary authority to enter into contracts of the type herein contemplated; and

44 WHEREAS, the purpose of this Cooperation Agreement is to establish the
45 mutual desire to cooperate to undertake, or to assist in undertaking, community renewal
46 and lower-income housing assistance activities, by means of submitting a Consolidated
47 Plan and Annual Action Plan for both HUD Community Development Block Grant Funds
48 (CDBG) as an Urban County from Federal Fiscal Years 2021, 2022, and 2023
49 appropriation, and from any program income generated from the expenditure of such
50 funds, and HUD HOME funds from appropriations in the same three Federal Fiscal
51 Years and from any program income generated from the expenditure of such funds; and

53 WHEREAS, the Committee on Economic and Community Development, at its
54 meeting of July 20, 2020, recommended adoption of File No. 20-462 (vote 4-0); now,

57 BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby
58 authorizes the Interim Director, Department of Health and Human Services, or her
59 designee, to enter into an Agreement with each of the 16 municipalities to establish the
60 mutual desire to cooperate to undertake, or assist in undertaking, community renewal
61 and lower-income housing assistance activities, by means of submitting a Consolidated
62 Plan and Annual Action Plan for both the United States Housing and Urban
63 Development (HUD) Community Development Block Grant Funds (CDBG) as an Urban
64 County from Federal Fiscal Years 2021, 2022, and 2023 appropriation, and from any
65 program income generated from the expenditure of such funds, and HUD HOME funds
66 from appropriations in the same three Federal Fiscal years and from any program
67 income generated from the expenditure of such funds.
