MINUTES

I. CALL TO ORDER AND ROLL CALL

Chair Guskowski, Eugene, called the meeting to order at 1:09 p.m.
Jill Knight Program Coordinator took the roll call; a quorum was present.

II. REVIEW AND APPROVAL OF THE JANUARY 9, 2026, SENIOR CENTER COMMITTEE MEETING MINUTES.

III. MCGOVERN SENIOR CENTER MOISTURE INVESTIGATION REPORT

Chair Eugene Guskowski requested permission from the committee to add a discussion item to the agenda regarding a newly released report on the McGovern Senior Center. He noted that the report was published recently and emphasized its importance. This item relates to the existing agenda topic, "Path Forward for Reimagining the Senior Centers," and is intended as an additional discussion point.

MOTION: Chair Guskowski made a motion to adjust the agenda to include this discussion item.

ACTION: Motion prevailed by unanimous consent (Behar Moved, Mayfield Second).

Daniel Idzikowski, Director of Aging Services, provided an update on the topic. He reported that Sigma completed a structural assessment of the McGovern building, identifying significant issues that make renovation challenging, though still possible. The assessment outlined two options: minimal repairs estimated at \$905,000 or comprehensive repairs totaling \$1,910,000 - the recommended solution to ensure long – term reliability and preventing escalating costs. No action was taken.

IV. MILWAUKEE SENIOR HUBS FOUNDATION

The group also discussed plans to reimagine senior centers and possibly create a foundation for support. No action was taken.
