

3 Professional Service Agreement with Ezekiel Community Development Corporation,
4 doing business as Ezekiel HOPE, to deliver Post-Release Skills Training Program
5 (PRSTP), by recommending adoption of the following:

7 **A RESOLUTION**

9 WHEREAS, on August 1, 2025, the Community Reintegration Center (CRC)
10 initiated a Request for Proposals (RFP) 2025-CRC-02 for a Post-Release Skills Training
11 Program (the Program) to support individuals transitioning from the CRC back into the
12 community; and
13

14 WHEREAS, following a comprehensive and competitive evaluation process, the
15 RFP submitted by Ezekiel Community Development Corporation (Ezekiel HOPE) was
16 determined to fully satisfy all requirements and evaluation criteria set forth in the RFP;
17 and
18

19 WHEREAS, on October 23, 2025, Milwaukee County issued a Notice of Intent to
20 Award, identifying Ezekiel HOPE as the selected vendor following a competitive
21 evaluation; and
22

23 WHEREAS, the Program provides vocational skills training, Occupational Safety
24 and Health Administration Outreach Training Program/Cardiopulmonary Resuscitation
25 certification, job-readiness training tools, safety equipment, and post-release
26 employment support for Program participants; and

28 WHEREAS, the Committee on Judiciary, Law Enforcement, and General
29 Services, at its meeting of December 9, 2025, considered File No. 25-726 for
30 informational purposes only, per Section 59.52(31)(d), Wisconsin State Statutes; and

32 WHEREAS, the Committee on Finance, at its meeting of December 11, 2025,
33 recommended adoption of File No. 25-726 (vote 6-0); now, therefore,
34

35 BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby
36 authorizes the Superintendent, Community Reintegration Center, to execute a
37 three-year Professional Service Agreement (the Agreement) with Ezekiel Community
38 Development Corporation, doing business as Ezekiel HOPE, to deliver the
39 Post-Release Skills Training Program, beginning on January 1, 2026, and shall continue
40 in full force and effect for an initial term of three years, ending on
41 December 31, 2028; and

43 BE IT FURTHER RESOLVED, thereafter, the parties may mutually agree in
44 writing to extend the Agreement for up to two additional one-year renewal terms, for a
45 total potential contract term of five years, contingent upon mutual agreement and
46 satisfactory performance; and

47 BE IT FURTHER RESOLVED, the contract amendment will only be executed
48 after review and approval by the Office of Economic Inclusion, Department of
49 Administrative Services (DAS), the Office of Corporation Counsel, and Risk
50 Management, DAS.
