- A. WE Energies needs to provide electric service to an existing location in Noyes Park at W. Good Hope Road. This expanded electrical service will connect to the updated irrigational system that serves the Noyes Park Golf Course.
- B. Revenue of \$2,660 will be realized based on \$1.60 per square foot for a 1,663 square foot easement. Staff time will be required for review of the Right of Entry application, but this review time will be compensated by the application fee.
- C. The revenue for the easement will help meet revenue targets for the budget year.
