A. The Director of the Department of Health and Human Services (DHHS) is requesting authorization to establish purchase of service contracts with several providers for case management services related to the Housing Division's Housing First initiative for the period June 1 through December 31, 2016.


Through these contracts, agencies will be able to provide case management services to approximately 125 homeless individuals and families.

B. This request reflects a total of \$152,000 in expenditures for the last seven months of 2016. For 2017, it is anticipated that the total annual cost will be \$260,568.

C. There is no tax levy impact associated with approval of this request in 2016. The cost of the contracts is anticipated to be absorbed by DHHS within its purchase of service contract budget line for 2016.

D. There are no additional assumptions.
