 - A. Approval of this resolution would authorize the creation of 3.0 FTE Civilian Investigator Full-time positions (Pay Grade22M) in 4052, General Investigations using the pool of funds from the vacant Investigator Hourly positions (Pay grade 22M) in 4052, General Investigations.
 - B. Funding for the positions is from budgeted funds for Investigator Hourly positions in 4052 General Investigations. These positions primary duty is to conduct employee background investigations for deputy sheriff, correctional officers, and civilian employees for MCSO as well as others throughout the county upon special request. The total costs for the 3.0 FTE positions starting as of period 1, 2024, are \$186,148 which reflects salary and social security. Total Investigator Hourly positions are budgeted at \$686,675 with social security. After using funds for creating the 3.0 FTE Civilian Investigator full-time position the remaining balance in the Investigator Hourly position budget will be \$132,880 with social security.
 - C. The 2024 total annual salary and social security for the position would be \$62,049 per FTE assuming an hourly rate of \$27.50 in pay grade 22M. In 2024 adopted budget we have the funds to reallocate to 3.0 FTE positions in 4052 General Investigations.
