

Report from the Director, Department of Health and Human Services, requesting authorization to execute non-professional service contracts with a network of caterers which support the Senior Nutrition Programs from January 1, 2026 through December 31, 2026 at a cost of \$2,862,754, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the Department of Health and Human Services hosts the Milwaukee County (the County) Area Agency on Aging (AAA), which oversees nutritional programs for older adults that are mandated and funded through the Older Americans Act (OAA) Title III-C; and

WHEREAS, the County's nutritional programs for older adults are known as the Senior Dining Program (the Program) and include both congregate dining within a network of senior dining sites and locally owned restaurants, as well as home-delivered meals, known locally as Meals on Wheels; and

WHEREAS, the purpose of the Program is to reduce hunger, food insecurity, and malnutrition, promote socialization among older adults, and promote the health and well-being of older adults, by assisting them to gain access to other services and supports; and

WHEREAS, the preparation and catering of meals is necessary to carry out the purposes of the Program; and

WHEREAS, the AAA is required to contract for most services provided through the OAA; and

WHEREAS, the Commission on Aging (COA), at its regular meeting of October 24, 2025, approved contracting with the meal preparation and catering vendors at the contracting rates listed below; and

WHEREAS, consistent with Section 59.52(31)(c), Wisconsin State Statutes (State Statutes), DHHS must bring contracts with a value or aggregate value of \$300,000 or more to the Milwaukee County Board of Supervisors (County Board) for authorization; and

WHEREAS, pursuant to Section 53.09 of the Milwaukee County Code of General Ordinances, the County Board has authority to review the allocations of funding made by the COA; and

WHEREAS, the Committee on Health Equity, Human Needs, and Strategic Planning, at its meeting of December 4, 2025, considered File No. 25-745 for informational purposes only, per Section 59.52(31)(d), State Statutes; and

WHEREAS, the Committee on Finance, at its meeting of December 11, 2025, recommended adoption of File No. 25-745 (vote 6-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes the Director, Department of Health and Human Services, or her designee, to execute non-professional service contracts with caterers that support the Senior Nutrition Program from January 1, 2026, through December 31, 2026, with the providers and at the rates listed below, at a cost not-to-exceed \$2,862,754:
