

MCDOT Airport Division

Major Initiatives for 2017

- Relocating Air Canada and United Airlines to Concourse C from Concourse E in anticipation of closing the Concourse E for redevelopment as an international arrival facility.
- Develop a central security checkpoint intended to be funded by a capital investment from a master concessionaire. RFP submissions for the concessions program are expected to generate more revenue and responses are due in the first quarter of 2017.
- GMIA seeks to expand Timmerman's role as Milwaukee County's General Aviation Airport. The LJT Business Plan is expected to be completed in 2017.

- GMIA Connection Taxiways Modifications -- \$3,162,000
- GMIA Replacement Jet Bridges -- \$1,500,000

- GMIA Runway 19R-1L,13-31/Taxiway S & Y Relamp -- \$1,097,000

MCDOT – Transportation Services

Major Projects/Initiatives for 2016

- Completed the jurisdictional transfer of S. North Cape Rd. (CTH J) from Hi-View Dr. to W. Forest Home Ave. in the City of Franklin.
- Substantially completed the construction of the roadway project on St. Martins Rd. (CTH MM) from S. North Cape Rd. to S. Lovers Lane (STH 100) in the City of Franklin.
- Substantially completed the construction of two bridge rehabilitation projects in Whitnall Park (Bridge # 713 & # 721) in the Village of Hales Corners and the City of Franklin.
- Collaborated with the City of Greenfield with roadway and other improvements (City Center) substantially completed by the City of Greenfield on W. Layton Ave. (CTH Y) from S. 45th St. to S. 76th St.
- Collaborated with the City of Milwaukee to include green initiatives and landscaping in the medians of E. Layton Ave. (CTH Y) from S. Howell Ave. to STH 794.



MCDOT – Transportation Services

Major Projects/Initiatives for 2017

- Complete the jurisdictional transfer of St. Martins Rd. (CTH MM) from S. North Cape Rd. to S. Lovers Lane (STH 100) in the City of Franklin.
- Complete the construction of the 2nd phase of the roadway project on W. Mill Rd. (CTH S) from N. 43rd St. to N. Teutonia Ave. in the City of Milwaukee.
- Complete the construction of the roadway project on W. Ryan Rd. (CTH H) from S. 96th St. to S. 112th St. in the City of Franklin.
- Complete the construction of two traffic safety improvement projects on S. 76th St. (CTH U) at the intersections of Edgerton Ave./Layton Ave. and Rawson Ave. (CTH BB) in the Cities of Greenfield and Franklin.
- Complete the construction of two bridge rehabilitation projects in Whitnall Park (Bridge # 564 & # 565) in the Village of Hales Corners.
- Continue the successful Short Term CTH Rehabilitation-Maint. Program.



MCDOT – Highway Maintenance

Major Projects/Initiatives for 2016

- Maintaining over 2,290 lane miles of Milwaukee County Highways, State Trunk Highways and Expressways.
- CityWorks project proceeded to the point of system testing.

Major Projects/Initiatives for 2017

- Will be fully live in the new State billing and work order system designed and built over the last two years in CityWorks.
- Seasonal shared Parks Highway Maintenance Workers are replaced in Highways with six full time positions



MCDOT Fleet Management Division

Major Projects/Initiatives for 2016

- Replaced 111 vehicles at \$6,423,000 as part of the ongoing vehicle replacement program.
- Awarded as one of the "Top 100 Fleets of the Americas"
- Achieved 98% employee productivity goal

Major Projects/Initiatives for 2017

 Scheduled to replace 162 vehicles at \$7,672,000 as part of the ongoing vehicle and equipment replacement program
