#### Policy

Per Wis. Stat. §59.52(31), contracts in excess of \$100,000, but less than \$300,000, require County Board passive review. Milwaukee County Parks seeks to enter into an agreement with the Milwaukee Metropolitan Sewerage District (MMSD) for the installation of a futsal court in Pulaski Park.

## Background

In December of 2016, the Milwaukee County Board of Supervisors approved a resolution, File No. 16-737, that transferred unused monies earmarked for the Community Identification Program to two new capital improvement projects. One of the projects was the installation of a futsal court in Pulaski Park. Capital Project WP-630 Pulaski Park Futsal Court was created and \$110,000 was transferred to the project. Currently, there is \$89,000 remaining in WP-630. Parks will transfer \$36,000 from its Bikes Trail Trust Fund to WP-630, making \$125,000 availabe for the project.

The construction and bidding climate resulted in funds not being adequate for the project; however, an opportunity to realize efficiencies in scale and proximity to contractors has presented itself through the Intergovernmental Cooperation Agreement with MMSD related to the Watercourse Restoration in Pulaski Park. The current budget of \$125,000 and related bid is competitive and Parks would like to move forward with the project to have the asset avaialbe to the public as soon as possible.

#### Recommendation

It is recommended that the Milwaukee County Board of Supervisors approve the agreement between Milwaukee County Parks and the Milwaukee Metropolitan Sewerage District (MMSD) for the installation of a







futsal court in Pulaski Park.

  - B. Approval of this agreement through passive review will allow the Parks Department to expend the remaining \$89,000 in WP-630. Additionally, \$36,000 will be transferred from the Bikes Trail Trust Fund, for a total project cost of \$125,000. An appropriation transfer request will be submitted to move the \$36,000 from the Bike Trails Trust Fund to Capital Improvement Project WP-630.
  - C. Sufficient funds are available in the Bike Trails Trust Fund to cover the additional \$36,000 needed for this project.
