A. The Director of CSS requests authorization to execute agreements to assist in the transfer of appropriate child support cases from Milwaukee County Circuit Court to the Oneida Tribal Court .


B. The Oneida Tribe will provide reimbursement for expenditures under this project, up to \$15,000. It is estimated that the project will take between one and one and one-half years, so this funding is likely to be expended partially in 2013 and partially in 2014.

C. Reimbursement will equal expenditures, so approval of this request will result in no additional levy impact. In light of this, the Director also asks that the Department of Administrative Services be authorized to implement a fund transfer to increase revenue and expenditure authority consistent with this project.
