

From the Director, Department of Transportation, requesting authorization to abolish one Fleet Mechanic position pay grade NR21, and create one Accounting Supervisor position, pay grade NR25 in the Department of Transportation-Fleet Management, by recommending adoption of the following:

AN ENGROSSED RESOLUTION

WHEREAS, the 2026 Adopted Budget includes 24 funded Fleet Mechanic positions in Fleet Management (FM), Department of Transportation (DOT); and

WHEREAS, the creation of an Accounting Supervisor position within FM, DOT, is necessary to create stronger financial oversight of the fiscal transactions that occur on a day-to-day basis; and

WHEREAS, this role will manage all accounting functions for FM, DOT, including general ledger maintenance, reconciliations, and financial reporting; and

WHEREAS, given the scope of responsibilities spanning strategy, compliance, and fiscal oversight, this role is essential for safeguarding public resources, improving service outcomes, and supporting the operational effectiveness of FM, DOT; and

WHEREAS, the Department of Human Resources has reviewed this position change request, determined the appropriate classification (Accounting Supervisor) and pay grade (NR25), and submitted a report included in this file; and

WHEREAS, the Office of Strategy, Budget, and Performance has reviewed this request with respect to need, appropriateness, and funding availability, as required by Section 59.60(10), Wisconsin State Statutes, and has submitted a report included in this file; and

WHEREAS, the Committee on Personnel, at its meeting of May 20, 2026, recommended adoption of File No. 26-397 (vote 3-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board) hereby approves the classification and pay grade recommendation for the position, as outlined in the report hereto attached and summarized below:
