11 This Agreement, made and entered into by and between the County of Milwaukee, a
12 municipal body corporate, as municipal employer, hereinafter referred to as "County",
13 and the Technicians, Engineers and Architects of Milwaukee County, as representatives
14 of employees who are employed by the County of Milwaukee, hereinafter referred to as
15 "Association".

19 In consideration of the mutual covenants herein contained, the parties hereto do hereby
20 mutually agree as follows:

22 **PART 1**

24 **1.01 RECOGNITION**

25 The County of Milwaukee agrees to recognize, and herewith does recognize, the
26 Technicians, Engineers and Architects of Milwaukee County as the exclusive collective
27 Bargaining agent of behalf of the employees of Milwaukee County in accordance with
28 the certification of the Wisconsin Employment Relations Commission, as amended, in
29 respect to wages, pursuant to Subchapter IV, Chapter 111.70, Wisconsin Statutes.

1 1.02 EMPLOYEE DEFINED

2 Wherever the term “employee” is used in this Agreement, it shall mean and include only
3 those employees of Milwaukee County within the certified bargaining unit represented
4 by the Association.

5
6 1.03 DURATION OF AGREEMENT

7 This Agreement is to take effect on January 1, 2023. Unless otherwise modified or
8 extended by mutual agreement of the parties, this Agreement shall expire on December
9 31, 2023.

13 2.01 WAGES

14 Effective Pay Period 8, 2023 (April 2, 2023) the wages of bargaining unit employees
15 shall be increased by two percent (2.0%).
