

**AMENDMENT TO
PROFESSIONAL SERVICE CONTRACT**

Milwaukee County, a Wisconsin municipal body corporate (hereinafter called "County"), represented by Paul Bargren, Corporation Counsel, and Whyte, Hirschboeck Dudek S.C. and Emile Banks and Associates LLC (hereinafter called "Contractors") entered into a contract for professional services for the case of Lloyd Johnson v. Milwaukee County, in November of 2014 (the "Contract"). The parties hereby agree to amend that contract, as follows:

COMPENSATION

The Compensation section of the Contract is hereby amended to provide that the total compensation to Contractor for services performed under the Contract shall not exceed Two hundred ninety-five thousand (\$295,000.00) unless agreed to by County in writing. At such time as the compensation for Contractor's services approaches Two hundred ninety thousand (\$290,000.00), Contractors and County will discuss entering into an extension or amendment of this Contract.

Except as set forth above, all provisions of the Contract and prior Amendments between the parties remain in force and effect.
