- A. The Office of the Comptroller is requesting the approval of the attached authorizing resolution and final bond resolution for the issuance of a not-to-exceed amount of \$27,400,000 of General Airport Revenue Refunding Bonds to refund the balance of the outstanding debt for the \$37,360,000 Series 2004A Airport Revenue Bonds (Series 2004A Revenue Bonds). The attached final bond resolution authorizes the issuance of the bonds and provides parameters for the issuance and delegates approval of the sale of the bonds to the Comptroller. The Comptroller's approval is limited to results of the sale that fall within parameters outlined in the resolution. An informational report will be submitted to the Finance, Personnel, and Audit Committee to communicate the final results of the bond sale.
  - B. The estimated net present values savings for the refunding is \$1,242,130 (or 4.57%). Total estimated debt service for the refunding is \$36,008,031. The not-to-exceed amount includes a total cost of \$200,000 for cost of issuance.
  - C. An administrative transfer will be submitted to the Department of Administrative Services to adjust the budget. The revenue is included in the bond issue amount.
  - D. The not-to-exceed amount of \$27,400,000 assumes the cost of issuance will not exceed the federally allowable 2% of the par value of the bonds. It also assumes Underwriter costs of \$3.25 per \$1,000 bond plus expenses. The estimated net present value amount is based on current market conditions (+50 basis points) and the previous airport bond sale that the County had in 2013.
