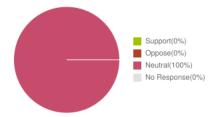

Overall Sentiment






