From the Director, Department of Health and Human Services, requesting authorization to abolish one FTE Aging Administrator position and to create one FTE Aging Unit Director position, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the 2021 Adopted Budget created one Full-Time Equivalent (FTE) Aging Administrator position to lead the Aging Division, Department of Health and Human Services, and to perform the duties of a FTE Aging Unit Director position in accordance with Section 46.82(5), Wisconsin State Statutes (State Statutes); and

WHEREAS, in addition to overseeing the functions of the Area Agency on Aging (AAA) and community-based services for older adults, this position was also intended to oversee the newly-merged Aging and Disability Resource Center (ADRC); and

WHEREAS, the necessary planning and application process to integrate both the Aging Resource Center and Disability Resource Center is underway, and will continue throughout 2021 with implementation of a combined ADRC to occur in 2022; and

WHEREAS, during the planning process, it was determined that the ADRC would roll up to the Aging and Disability Division Administrator, and the proposed Aging Unit Director position would oversee the AAA and Senior Centers; and

WHEREAS, specifically, the Aging Unit Director would fulfill the requirements under Section 46.82(5), State Statutes, in providing strategic leadership, overseeing the AAA, community-based services for older adults, and activities that support the operational and policy work of the Commission on Aging to ensure the success of programs and meaningful involvement of older adults; and

WHEREAS, there will be no tax levy impact for this position; and

WHEREAS, the Committee on Finance, at its meeting of May 13, 2021, recommended adoption of File No. 21-393 (vote 7-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes and approves the abolishment of one Full-Time Equivalent (FTE) Aging Administrator position, and the creation of one FTE Aging Unit Director position to be filled beginning in Pay Period 12:
