From the Director, Milwaukee County Zoo (the Zoo), requesting authorization to amend Section 47.32(b) of the Milwaukee County Code of General Ordinances regarding a \$1.25 increase in all zoo admission categories, effective April 1, 2018, in order to conform with the 2018 Adopted Budget, by recommending adoption of the following:

A RESOLUTION/ORDINANCE

WHEREAS, the Milwaukee County Zoo (the Zoo) provides an updated list of fees in every annual budget; and

WHEREAS, the Milwaukee County Board of Supervisors deliberate and approve the fees proposed to raise revenue for each department; and

WHEREAS, the Zoo has proposed an increase in fees for entrance to the facility in 2018; and

WHEREAS, the Committee on Parks, Energy, and Environment, at its meeting of March 13, 2018, recommended adoption of File No. 18-173 (vote 4-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby amends Section 47.32(b) of the Milwaukee County Code of General Ordinances by adopting the following:

AN ORDINANCE

The County Board of Supervisors of the County of Milwaukee does ordain as follows:

SECTION 1. Section 47.32(b) of the General Ordinances of Milwaukee County is hereby amended as follows:

47.32. - Admission charges and parking fees at the county zoo and Mitchell Park Conservatory.

- (a) The following fees shall be charged for admission to the Mitchell Park Conservatory: From 9:00 to 10:30 a.m., Monday through Friday, excluding major holidays, no charge for a resident of the county; for persons residing outside of the county, the admission fee shall be three dollars (\$3.00) for adults and one dollar and seventy-five cents (\$1.75) for children under eighteen (18) years of age, the disabled and senior citizens presenting a county older adult I.D. card or other valid, legal form of identification. Nonresident senior citizens will be charged the regular adult admission fee of three dollars (\$3.00). Minimum evening rental fee shall be four hundred dollars (\$400.00) plus four dollars and fifty cents (\$4.50) per person.

(b) Except as provided in subsection (d) hereof, the following fees shall be charged for admission to the county zoo: ~~From 9:00 a.m. to closing every day,~~ the admission fee shall be ~~fourteen~~ fifteen dollars and ~~twenty-five~~ fifty cents (~~\$14.25~~15.50) for nonresident adults, ~~eleven~~ twelve dollars and ~~twenty-five~~ fifty cents (~~\$11.25~~ 12.50) for nonresident children twelve (12) years of age or younger, ~~twelve~~ thirteen dollars and ~~fifty~~ seventy five cents (~~\$12.50~~13.75) for county resident adults, ~~nine~~ ten dollars and ~~fifty~~ seventy five cents (~~\$9.50~~10.75) for county resident children twelve (12) years of age or younger, ~~thirteen~~ fourteen dollars and ~~twenty-five~~ fifty cents (~~\$13.25~~14.50) for nonresident senior citizens and ~~eleven~~ twelve dollars and ~~fifty~~ seventy five cents (~~\$11.50~~12.75) for county resident senior citizens presenting an older adult I.D. card, or other valid, legal form of identification, ~~ten~~ eleven dollars and ~~twenty-five~~ fifty cents (~~\$10.25~~11.50) for nonresident education adult, ~~nine~~ ten dollars and ~~fifty~~ seventy five cents (~~\$9.50~~10.75) for county resident education adult, ~~seven~~ eight dollars and ~~twenty-five~~ fifty cents (~~\$7.25~~8.50) for nonresident education junior, ~~six~~ seven dollars and ~~fifty~~ seventy five cents (~~\$6.50~~7.75) for county resident education junior, ~~twelve~~ dollars (~~\$12.00~~) \$11.50 for nonresident group adult, ~~ten~~ dollars and ~~twenty-five~~ eleven dollars and ~~fifty~~ cents (~~\$10.25~~11.50) for county resident group adult, ~~nine~~ dollars (~~\$9.00~~) 8.50 for nonresident group junior, ~~seven~~ eight dollars and ~~twenty-five~~ fifty cents (~~\$7.25~~8.50) for county resident group junior. The above fees apply from April 1 through October 31. From November 1 through March 31, the following fees shall be charged: ~~eleven~~ thirteen dollars and ~~seventy-five~~ cents (~~\$11.75~~13.00) for nonresident adults, ~~eight~~ ten dollars and ~~seventy-five~~ cents (~~\$8.75~~10.00) for nonresident juniors, ~~ten~~ eleven dollars and ~~twenty five~~ cents (~~\$10.00~~11.25) for county resident adults, ~~seven~~ eight dollars and ~~twenty five~~ cents (~~\$7.00~~8.25) for county resident juniors, ~~ten~~ eleven dollars and ~~twenty-five~~ fifty cents (~~\$10.25~~11.50) for nonresident senior citizens and ~~eight~~ nine dollars and ~~fifty~~ seventy five cents (~~\$8.50~~9.75) for county resident senior citizens presenting an older adult I.D. card, or other valid, legal form of identification. The admission fee shall be ~~eight~~ nine dollars and ~~twenty five~~ cents (~~\$8.00~~9.25) for adults and ~~five~~ six dollars and ~~fifty~~ seventy five cents (~~\$5.50~~6.75) for children every Wednesday of each month for county residents, except holidays. Admission fees are waived for county residents on Thanksgiving, Christmas and New Year's. There will be one (1) free day per month for both county and non-county residents, from January through ~~April~~ March, and in October, November and December. In all instances, parking fees will continue to be charged.

89 (c) Except as provided in subsection (d) hereof, the following fees shall be
90 charged for parking at the county zoo parking lot: twelve dollars (\$12.00)
91 per car at all times when the zoo is open to the general public; sixteen
92 dollars (\$16.00) per bus whenever the zoo is open to the general public;
93 five dollars (\$5.00) per car charged for zoological society sponsored
94 private events held at the zoo during the evening.

95
96 (d) The zoo director is authorized to waive admission and bus parking
97 charges for handicapped groups, county educational groups and members
98 of the Zoological Society of Milwaukee County, including spouses and
99 minor children.
