The extension of Darlene Fuller's temporary assignment to higher classification (TAHC) for a maximum of an additional eight weeks, from April 4 to May 30, 2015, will increase district attorney personnel costs by approximately \$255 in salary and FICA costs ( $\$0.74/\text{hr.} \times 320 \text{ hrs.} = \$237$ ;  $\$237 \times 1.0765 = \$255$ ).

Fuller is paid at step 1 of pay range 07PM for her TAHC, an increase of only 74 cents per hour above her pay as a clerical assistant 1. The previous incumbent's pay was at the top step of pay range 07PM, so the actual costs of the position, including Fuller's TAHC, are less than the 2015 budgeted cost of the senior executive assistant (NR) position.
