AN ORDINANCE

The County Board of Supervisors of the County of Milwaukee does ordain as follows:

SECTION 1. Section 17.30(2) of the General Ordinances of Milwaukee County is hereby amended as follows:

17.30. Confirmation of appointments to certain unclassified positions and terms of such appointments.

(2) In accordance with subsection (1) of this section all appointments to positions of department heads in the unclassified service and appointments to all management positions in the unclassified service responsible for a function which could organizationally be structured as a separate department shall require confirmation by the county board and shall serve a term of office which commences upon the date approved by the county board and expires six (6) months after expiration of the term of office of the county executive or county board chairperson in office at the time of appointment. The following positions shall be subject to this provision:

SECTION 2. Section 17.30(6) of the General Ordinances of Milwaukee County is hereby amended as follows:

17.30. Confirmation of appointments to certain unclassified positions and terms of such appointments.

(6) After January 1, 2000, appointments to the position of Executive director - 3 House of correction superintendent shall be made by the sheriff. Appointee to the position of Executive director - 3 House of correction superintendent or to any comparable successor position, however denominated, the primary duties of which involve the administration of the house of correction, shall be supervised by and serve at the pleasure of the sheriff.

(6) Appointments to the position of Executive director - 3 House of Correction Superintendent shall be made by the County Executive. The County Executive shall supervise the administrative duties of the House of Correction Superintendent or any comparable successor position, however denominated. The Superintendent for the House of Correction supervisor shall serve at the pleasure of the County Executive.

SECTION 3: This ordinance shall become effective upon publication.
