REQUEST

Requesting authorization to grant waivers to special event organizers for events that impede access to Lincoln Memorial Drive on various dates in 2023.

POLICY

Milwaukee County Ordinance 47.031(5) requires any event sponsor who wishes to conduct an event that impedes access to Lincoln Memorial Drive (LMD) to petition the Milwaukee County Board of Supervisors through the Committee on Parks, Energy and Environment, for a waiver if their event does not conform to one or more conditions or restrictions listed in Chapter 47.031 (1) to (4).

BACKGROUND

To date, seven event organizers have applied for Parks special event permits that would impede access to Lincoln Memorial Drive (LMD) on various dates in 2023. A list of those events is attached. These events have brought thousands of participants and visitors to Milwaukee that increase exposure and contribute directly to our local economy.

Event organizers are to pay all Parks fees required for closing LMD and permitting to host its event on park property. They must also apply for and receive permits from the City of Milwaukee as necessary. Discussions with lakefront stakeholders will occur and every effort will be made to minimize business interruption along the routes. McKinley Marina tenants, Sailing Center members, Milwaukee Yacht Club members, and other lakefront partners will have access during all closures. Access to lakefront venues will be coordinated with the Milwaukee County Sheriff's Office as well as the Milwaukee Police Department.
