6 **AN ENGROSSED RESOLUTION**

8 Urging state lawmakers to support the "Keep Families Together" bill package to protect
9 immigrants in Wisconsin

12 WHEREAS, Milwaukee County is committed to keeping all residents safe and
13 supported, valuing the contributions of immigrant communities even in the face of
14 federal policies that threaten families and foster fear; and
15

16 WHEREAS, representatives in the Wisconsin legislature have introduced the
17 "Keep Families Together" bill package, which includes five bills that protect immigrants
18 in Wisconsin by:
19

- 20 • Requiring law enforcement officers and agents to clearly identify themselves
21 – including name, badge number, authority for the arrest, and an uncovered
22 face – when detaining or arresting an individual
- 23 • Requiring Wisconsin's Department of Administration to award grants to
24 Wisconsin-based organizations with a proven record of providing immigration-
25 related civil legal services, while also allowing counties to fund organizations
26 that provide civil legal services
- 27 • Prohibiting state and local entities from allowing their facilities or funds to be
28 used for detaining individuals solely based on immigration status or for
29 establishing or operating immigrant detention facilities in Wisconsin
- 30 • Prohibiting state and local officials from aiding detentions based solely on
31 immigration status and banning all state or local participation in 287(g)
32 immigration enforcement agreements
- 33 • Prohibiting state and local officials from aiding or funding immigration-based
34 detentions in public buildings, schools, places of worship, child care, or health
35 care facilities

39 WHEREAS, the "Keep Families Together" bill package, includes **2025 Assembly**
40 **Bills 57, 441, 444, 475, and 739** ~~Legislative Reference Bureau (LRB) 25-4042,~~
41 ~~25-4207, 25-4475, 25-4415 (drafts not yet formally introduced and assigned a bill~~
42 ~~number) and Assembly Bill (AB) 25-57;~~ and

44 WHEREAS, all Milwaukee County residents, regardless of citizenship or
45 immigration status, are entitled to due process of law and equal protection under the
46 Fourteenth Amendment of the United States Constitution; and

48 WHEREAS, the Committee on Intergovernmental Relations, at its meeting of
49 December 1, 2025, recommended adoption of File No. 25-783 (vote 3-0); now,
50 therefore,

52 BE IT RESOLVED, Milwaukee County affirms its dedication to prioritizing
53 keeping families together and remaining a safe place for immigrants who contribute to
54 the richness and vibrancy of the community; and
55

56 BE IT FURTHER RESOLVED, the Milwaukee County Board of Supervisors
57 urges the Wisconsin State Legislature to support the "Keep Families Together" bill
58 package **and other legislation that may be proposed with similar intent**; and

60 BE IT FURTHER RESOLVED, that the Milwaukee County Office of Government
61 Affairs is authorized and requested to communicate the contents of this resolution to the
62 Governor, members of the Wisconsin State Legislature and the Wisconsin Counties
63 Association to promote the "Keep Families Together" bill package.
