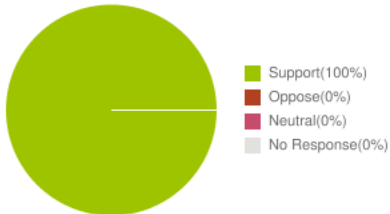

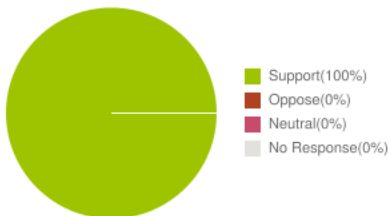

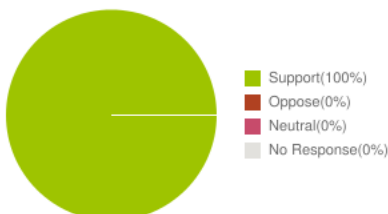

I'm thrilled that CAMPAC has revised its method of allocating funds with racial equity in mind, and that the county continues to invest in arts and culture programming. Here is one of many, many comments from Ex Fabula participants that show the healing and growth that is possible when we invest in arts and culture. It comes from Elijah, a Milwaukee School of Languages student who first participated in our storytelling workshops as part of the 2020 Milwaukee Public Library Teen Summer Challenge; he then attended our Brave Space workshops, which are affinity spaces for BIPOC folks, which led to him telling a personal story about how he got help after a mental health crisis at our "Reimagining Self" StorySlam.

"I've had to tell (my story) thousands of times, cuz therapy and all that. When you're telling a story, it's not just making a timeline. You're trying to wrap people up, in your experience, as if they had been there. So to do that, you have to convey emotion in your story, which was a difficult thing for me to do because it was a very emotional time.

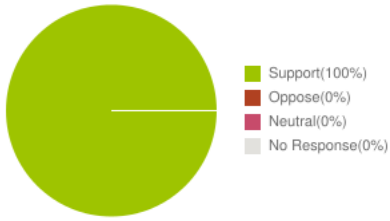
"Because of that, I had to reflect even more than I had about the event. So when I finally told the story, even though it was the shortest way I've ever told it, it was probably also the truest way. _I resolved some things for myself during the whole storytelling process."

Clearly, the arts are not extra - they are vital to our collective health and happiness. Thank you for funding the arts through CAMPAC, and I hope you will also advocate for additional investments in the arts going forward.
