Approval of this resolution/ordinance will amend Section 1.21 of the Milwaukee County Code of General Ordinances so that all appointments, including reappointments, be referred to the appropriate standing committee for review and consideration. Currently, County Board members and members of any board or commission nominated for reappointment to their own position are placed directly on the County Board Digest and are not referred to a standing committee.
  - B. There are no direct costs related to this resolution, other than minor costs for the Office of the County Clerk to publish the revised ordinance. Additional staff time will be needed to coordinate appointee appearances at standing committee meetings. During the 2024-2026 County Board legislative term, 41 reappointments were placed directly on the County Board Digest for confirmation.
  - C. There are no budgetary impacts in 2026 or subsequent years.
  - D. No assumptions were used.
